Applicant(s), including all principals and owners, must be at least 19 years of age and must apply in person to the Business Licence Inspector with the \$1500.00 licence fee, one (1) police records check, and two (2) pieces of identification, one of these pieces being government issued picture ID.

Conducting business without a Business Licence is an offence for which penalties are prescribed. The minimum penalty is a fine of \$100.00 per day for each day that the offence continues, pursuant to Section 4 of the 'Business Licence Bylaw.'
