### About the Greater Victoria Public Library Board

The Greater Victoria Public Library Board (GVPL Board) provides joint management, maintenance, improvement, operation and control of ten library branches in member municipalities. The GVPL Board consists of nineteen members, including one Council member and four citizen appointees from the City of Victoria. ### About this Opportunity

An opportunity is available for three citizen appointees to serve on the GVPL Board for a term starting on January 1, 2016 and ending December 31, 2017. Citizen appointees must have resided in the City of Victoria for at least six months preceding the appointment. Citizen appointees serve two-year terms to a maximum of four consecutive terms (or eight consecutive years).
