BYLAW NOTICE ADJUDICATION BYLAW

A BYLAW OF THE CITY OF VICTORIA

(Consolidated to include Bylaws 20-032, 20-033, 22-062, 23-035, 23-068, 23-108, 23-155, 24-023, 24-046, 24-072, 25-022, 25-025, 25-043, 26-005, 26-024)

The purpose of this Bylaw is to establish a bylaw notice dispute adjudication system and designate bylaw contraventions that are to be enforced by bylaw notice under the *Local Government Bylaw Notice Enforcement Act*.

Under its statutory powers, including sections 2, 4 and 14 of the *Local Government Bylaw Notice Enforcement Act*, the Council of the Corporation of the City of Victoria, in an open meeting assembled, enacts the following provisions:

Title

1 This Bylaw may be cited as the “Bylaw Notice Adjudication Bylaw.”

Definitions

2 In this Bylaw:

“Act”

means the *Local Government Bylaw Notice Enforcement Act*;

“bylaw notice”

means a bylaw notice referred to in section 4 of the Act and issued under this Bylaw;

“City”

means the Corporation of the City of Victoria;

“Council”

means the Council of the Corporation of the City of Victoria;

“screening officer”

23-068 means a person designated and appointed under section 8 of this Bylaw to act as a Screening Officer I, Screening Officer II, Screening Officer III, Screening Officer IV, Screening Officer V, Screening Officer VI, Screening Officer VII or Screening Officer VIII

Schedules

3 The schedules attached to this Bylaw form part of this Bylaw.

Bylaw contraventions

4 The bylaw contraventions set out in Schedules A through SS are designated as contraventions which may be enforced by bylaw notice.

Penalty

5 (1) The amounts appearing under column A of each of Schedules A through SS are the penalties set for the corresponding contraventions designated in the “Bylaw Section” and “Description” columns of each Schedule.

(2) If payment is received by the City within 14 days of the person receiving or being presumed to have received the bylaw notice, then the penalty set out in Column A of each of Schedules A through SS is reduced by the corresponding discount amount set out in Column B of each Schedule.

(3) If payment is not received by the City 15 days after the person received or is presumed to have received the bylaw notice, then the penalty set out in Column A of each of Schedules A through SS is increased by the surcharge amount set out in Column C of each Schedule.

Paying or disputing notice

6 (1) A bylaw notice may be delivered

- (a) in person to the named person,
- (b) by mailing a copy of the bylaw notice

- (i) if the bylaw notice is in respect of a contravention involving a vehicle, to the address for each registered owner of the vehicle involved,
 - (ii) to the actual or last known address of the named person, or
 - (iii) if the named person is a corporation or a business, to the registered office or head office, or
- (c) if the bylaw notice is in respect of a parking contravention, by leaving the bylaw notice on the vehicle involved.
- (2) A bylaw notice delivered under subsection (1)(b) is presumed to have been received by the person to whom it is addressed on the 7th day after mailing.
- (3) A bylaw notice delivered under subsection (1)(c) is presumed to have been received by each registered owner of the vehicle on the day it is left on the vehicle.
- (4) A person who receives a bylaw notice, or their authorized agent, must, within 14 days of the date on which the person received or is presumed to have received the bylaw notice
 - (a) pay the penalty, or
 - (b) request dispute adjudication
 by following the appropriate instructions on the bylaw notice.
- (5) A person may pay the indicated penalty after 14 days of receiving a bylaw notice, but no person may dispute a bylaw notice after 14 days of receiving the bylaw notice.

Bylaw notice dispute adjudication system and notice dispute fee

- 7 (1) A bylaw notice dispute adjudication system in accordance with Part 3 of the Act is hereby established in order to resolve disputes in relation to bylaw notices.
- (2) Every person who is unsuccessful in a dispute adjudication in relation to a bylaw notice under the dispute adjudication system established under this section shall pay an administrative fee of \$25.00, in addition to any other penalty amount imposed under this Bylaw.

Screening officers

- 8 (1) The positions of Screening Officer I, Screening Officer II, Screening Officer III, Screening Officer IV, Screening Officer V, Screening Officer VI, Screening Officer VII, and Screening Officer VIII are hereby established.

- (2) Council hereby designates all persons employed by the City as a Bylaw Officer, as persons that may be appointed as a Screening Officer I, and hereby appoints them as Screening Officers I.

- (3) Council hereby designates all persons employed by the City as a Manager-Parking Services, Supervisor – Parking Services, Manager-Revenue, Director of Finance, and Director of Citizen Engagement and Strategic Planning, and Parking Review Representative as persons that may be appointed as Screening Officer II, and hereby appoints them as Screening Officers II.
- (4) Council hereby designates all persons employed by the City as a Short-Term Rental Coordinator as persons that may be appointed as a Screening Officer III, and hereby appoints them as Screening Officers III.
- (5) Council hereby designates all persons employed by the City as an Animal Control Officer as persons that may be appointed as a Screening Officer IV, and hereby appoints them as Screening Officers IV.
- (6) Council hereby designates all persons employed by the City as a Building Inspector as persons that may be appointed as a Screening Officer V, and hereby appoints them as Screening Officers V.
- (7) Council hereby designates all persons employed by the City as an Electrical Inspector as persons that may be appointed as a Screening Officer VI, and hereby appoints them as Screening Officers VI.
- (8) Council hereby designates all persons employed by the City as a Fire Prevention Officer as persons that may be appointed as a Screening Officer VII, and hereby appoints them as Screening Officers VII.
- (9) Council hereby designates all persons employed by the Victoria Police Department as a Police Constable as persons that may be appointed as a Screening Officer VIII, and hereby appoints them as Screening Officer VIII.
- (10) Every screening officer in a class listed in Column 1 of Schedule UU has the power to review disputed bylaw notices issued in relation to the bylaw, bylaws, or specific bylaw contraventions identified in Column 2 of Schedule UU opposite the respective screening officer class, including the power to:
 - (a) cancel a bylaw notice if in the opinion of the screening officer
 - i. the contravention did not occur as alleged,
 - ii. the bylaw notice does not comply with section 4(4) of the Act, or
 - iii. cancellation is in accordance with the City's policies and procedures with respect to the cancellation of a bylaw notice;

- (b) prepare and enter into compliance agreements under the Act with persons who dispute bylaw notices for each contravention, including to establish terms and conditions for compliance that the screening officer considers necessary or advisable, including time periods for payment of penalties and compliance with the bylaw;
- (c) provide for payment of a penalty reduced from the amount shown in Column A of Schedule MM Streets and Traffic Bylaw Contraventions and Penalties - Parking to an amount that is either:
 - i. the parking fee that was incurred at the time of the contravention, or
 - ii. the parking fee that would have been incurred had the vehicle been parked in the metered zone or ticket controlled zone closest to the location of the contravention

if a compliance agreement is entered into and all of the terms of the compliance agreement are observed or performed;

- (d) provide for payment of a penalty reduced by one half of the amount shown in Column A of Schedules A through LL and NN through SS if a compliance agreement is entered into and all of the terms of the compliance agreement are observed or performed; or
 - (e) Confirm the bylaw notice and refer it to an adjudicator unless the request for dispute adjudication is withdrawn.
- (11) The specific bylaw contraventions in relation to which a screening officer may enter into a compliance agreement are indicated in Column 3 of Schedule UU opposite the respective screening officer class in Column 1 of Schedule UU.
- (12) Compliance agreements in relation to any contravention identified in Schedules A through LL and NN through SS must be in the form attached to this Bylaw as Schedule TT.
- (13) The maximum duration of a compliance agreement is one year.

Severability

- 9 If any provision of this Bylaw is found to be invalid by a Court of competent jurisdiction it may be severed from the Bylaw and the remainder of this Bylaw is deemed to have been adopted without the severed section, subsection, paragraph, subparagraph, clause or phrase.

Effective date

10 This Bylaw comes into force on March 1, 2016.
