B.1 Minutes from the meeting held July 16, 2024

C. 2024-2025 IDPAD Youth Grant Program

The Equity, Diversity and Inclusion Lead provided an overview of the IDPAD Youth Grant Program and the review process for considering grant applications for 2024/2025 grant recipients.

Committee discussed the following:

- *Value in convening a separate meeting to discuss the committee's terms of reference.*
- *Continuation of the IDPAD Decade to align with international, national and provincial commitments to permanent IDPAD Forum and advancing IDPAD priorities*
- *Aim to maximize the number of grants given*
- *Improving visibility of the IDPAD committee in the community*

- *Opportunities for the IDPAD Committee to apply for external grants to redistribute into and benefit the community*
- *Strategies to provide additional cost savings for grant applicants*
 - *sponsorships, facility bookings discounts, etc.*
 - *In-kind donations and contributions*
 - *Implementing language in the grant application form to inform applicants of opportunities for additional cost-savings or support*
- *Eligibility criteria*
 - *Will 2023/2024 recipients be eligible for the next round?*
 - *Strategizing priority project types*
- *Perceived conflicts of interest*
 - *Committee members to declare any conflicts when applications are received*
 - *Avoid perception of conflicts by including a disclosure statement on grant application form about the committee's commitment to avoiding conflicts of interest*

C.1 - Priorities & Approaches

Committee discussed the following:

- *No changes to priorities*
- *Grant program remains open to a wide range of programs*
- *Eligible programs must be youth-run*

C.2 – Timelines

Committee discussed the following:

- *Applications close November 13, 2024*
- *IDPAD Committee to discuss applications on November 19th with an additional meeting on November 22nd, as needed*
- *Grants to be awarded by end of November*
- *December – IDPAD committee strategy meeting*
- *January 2025 – IDPAD committee to meet with grantees*

C.3 – Other

Committee discussed the following:

- *IDPAD committee's ability to combine other partnerships or contributions to supplement amounts awarded under the IDPAD Youth Grant*
- *Creation of a communications plan to improve support for the community.*
 - *IDPAD committee members to work toward a shared vision of the intent and purpose of the committee*
 - *Update the Terms of Reference to reflect this vision*
 - *Role of IDPAD committee in healing community through its role with the City of Victoria*
