- *The fact that the Committee has until the end of 2024 to conduct the three workshops*
- *Benefits of facilitating more introductions and interactions between City staff and the Black community*
- *Being able to combine ideas and resources through systems of thinking*
- *Proposed plans and ideas for workshops to be discussed next meeting*
