Bylaw Services Presentation

The Committee received a presentation from Adam Sheffield, Manager, Bylaw & Licensing. Mr. Sheffield provided details on the Bylaw Services daily tasks, challenges, perceptions of the public, and different barriers that people who are unhoused face.

Examples of barriers provided:

- Lack of affordable housing
- Stigma from their conditions and their homeless condition
- Addiction and mental health
- Colour blindness
- Lack of family support
- Procedural challenges

Committee discussed the following:

- a. *Hiring members from different cultural backgrounds*
- b. *Giving presentation to communities of African descent/ new immigrants*
- c. *Inviting members of the committee to tag alone during their rounds on the streets*
- d. *The importance of building trust with the unhoused community*
- e. *The importance of building a relationship between the Bylaw Services and the IDPAD committee*
- f. *Barbara suggested to Adam to attend the sober festival. Suggesting that this could be a place where, the bylaw office could set up a booth and hand out information about the work they do in the community*
