



City of Victoria Campership Fund

About the Program

The City of Victoria believes every child and youth deserves the chance to attend summer camp. Our Campership Program aims to remove financial barriers in order to increase access to fun camp experiences.

The Campership Program supports children and youth aged 4-15 living with a low-income to access one week of free summer camp. ***While Campership aims to support as many families as possible, due to limited funds available not every application will be awarded Campership.***

Successful applicants will be selected via lottery system. Families may apply for up to two children per household to be entered into the draw. **Applications must be submitted by the deadline to be considered for Campership.** Successful applicants will be notified via email.

The Campership Program is generously funded by public donations and community partners.

Eligibility Requirements:

Children between the ages of 4-15 years are eligible for the Campership Program.

Household income must be at or below the following levels to qualify:

**Numbers are determined by the Statistics Canada low-income threshold, including inflation changes in the regional cost of living allowance.*

Guidelines:

- Campership funding is available only for Crystal Pool & Fitness Centre programs.
- Funding for the Campership program is not redeemable for cash value; no refunds are given on Camperships and is not transferable from one year to the next.
- All information provided in the application remains confidential.
- Maximum subsidy for 2 children/family for camps between ages 4-15 yrs. A maximum of one campership will be awarded per child per year.
- Only applications that have been received by our deadline will be considered.
- Campership offerings are limited and are selected through a lottery-based selection process.
