## WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT

**Release** – I/we hereby remise, release and forever discharge the Releasees from any and all claims, actions, demands, obligations, liabilities, costs and expenses whatsoever, whether direct or indirect, including without limitation with respect to any damage to person or property, that I may suffer or incur, due to any cause whatsoever including negligence or breach of any statutory or other duty of care, as a result of the issuance of the Permit or any inspection or action undertaken by the City as a result of the Permit.

**Indemnity** – I hereby agree to indemnify and hold harmless the Releasees from and against any and all claims, actions, demands, obligations, liabilities, costs or expenses whatsoever and howsoever arising, including arising out of or with respect to any damage to any person or property incurred by myself, the party for whom I act as agent, or any other party, which may in any way arise or accrue against the Releasees as a result of or incidental to the issuance of the Permit.

**No Representations, Warranties or Guarantees** –The City has not made any representations, warranties or guarantees with respect to any matter relating to the Permit or any work to be undertaken pursuant to the Permit, including without limitation compliance with City bylaws or any other provincial or federal act or regulation in force in the City. I hereby agree that I will be solely responsible for ensuring that all work carried out pursuant to the Permit is in compliance with all applicable City bylaws and any other provincial or federal act or regulation in force in the City. I further agree that I do not rely on the City to notify me of any defects in this permit application or supporting documentation and that any inspection or other actions undertaken by the City are not intended to ensure and will not ensure that any work complies with the applicable City bylaws or any other provincial or federal act or regulation in force in the City.
