Under its statutory powers, including sections 260 to 273 of the *Community Charter*, the Council of the City of Victoria enacts the following provisions:

Title

- 1 This Bylaw may be cited as the "TICKET BYLAW".

Bylaws enforced by ticket

- 2 The bylaws and bylaw provisions listed in Column 1 of Schedule A may be enforced by means of a ticket in the form prescribed for the purpose of section 264(1)(a) of the *Community Charter*.

Bylaw enforcement officers

- 3 The persons appointed to the job positions or titles listed in Column 2 of Schedule A are designated as bylaw enforcement officers under section 264(1)(b) of the *Community Charter* in relation to each of this Bylaw and the Bylaw Notice Adjudication Bylaw No. 16-017, unless otherwise indicated in Column 2 of Schedule A.

Description of offences

- 4 Pursuant to section 264(4) of the *Community Charter*, the words or expressions set out in Column 1 of Schedules B onwards designate the offence committed under the bylaw section appearing under Column 2 opposite the respective words or expressions.

Set fines

- 24-073 5 Pursuant to section 265(1)(a) of the *Community Charter*, the amounts appearing under Column 3 of Schedules B onwards are the fines set for the corresponding offences designated in Column 1 of each Schedule.

Reduced fines

- 24-073 6 The amounts appearing under Column 4 of Schedules B onwards to this bylaw are the discounted fines pursuant to section 265(2) of the *Community Charter* for the corresponding fines set in Column 3 of each Schedule provided that the Municipal Ticket Information is paid within 30 calendar days upon receipt.

Repeal

- 7 Bylaw No. 10-043, the Ticket Bylaw, is repealed.
